



## **Title IX, Part A McKinney-Vento Program Families in Transition**

### **Parents, Guardians and Caregivers**



If your family is in a temporary or inadequate living situation due to a loss of housing, your child might be eligible for certain educational rights and services.

#### **Free, Appropriate, Public Education**

Enroll in eligible school immediately, even if lacking documents normally required for enrollment.



Enroll in eligible school and attend classes while the school gathers needed documents.

Enroll in the local school or continue attending the school of origin (school attended while permanently housed or school in which child was last enrolled), if that is your preference.



#### **Transportation**

Receive transportation to and from school of origin, if requested.

#### **Connection with Local Agencies**

Work with school counselors to connect with local agencies.



### **Materials and Resources for Success in School**

School Supplies  
(Including support for accessing the Internet as needed for educational purposes).

Hygiene Products

School Appropriate Clothing

Free Breakfast and Lunch  
(Weekend food packs where available)



#### **Fee Exemptions and Waivers**



Fee waivers for extended day programs as long as instructional support is included.

Fee waivers for college entrance assessments.

Tuition and fee exemptions for students to attend school district career centers, charter technical care centers, public colleges and state universities in Florida.



## Title IX, Part A McKinney-Vento Program Families in Transition

### Who Qualifies



Individuals who lack a fixed, regular, and adequate nighttime residence including...

#### Doubled-Up

Children and youths who are temporarily sharing the housing of other persons due to loss of housing, economic hardship, or other similar reason.



#### Hotels, Motels, Campgrounds

Children and youths who are living in motels, hotels, trailer parks, or campgrounds due to the lack of alternative adequate accommodations.

#### Emergency or Transitional Shelters

Children and youths living in emergency or transitional shelters due to a crisis such as loss of housing, a natural disaster, man-made disaster, or domestic violence.



#### Substandard Housing

Children and youths who are living in housing that lacks running water, heating, electricity, doors or windows.

Housing not intended for nighttime residency such as barns, sheds or abandoned buildings.

#### Lacking Shelter

Children and youths who are living in cars, parks, public spaces, train or bus stations or similar settings.



#### Migratory Children

Children or youths who are defined as "Migratory" living in any of the circumstances described above.
